Vice President Ray called the October 8, 2014 meeting to order at 7:32 pm.

Health Officer's Report

September Report Summary:

Discussion items were reviewed at this time.

- Child Health Clinic

Staff continues to explore potential venue locations within the Borough of Hightstown to serve as host sites for the Clinic. Faith-based organizations, medical offices and various public buildings were reviewed and/or contacted as potential sites. Staff and Board Members will continue with outreach within the community. Ms. Swanson has explored a shared service agreement as an alternate plan for 2015 if needed.

- Enterovirus- D68

A brief overview was provided. The Health Department has been engaged in community outreach and education including a presentation to the Mercer Chapter of the NJ Schools Buildings and Grounds Association, infection control educational sessions for kindergarten and first graders, site visits and literature to childcare facilities and distribution of educational materials throughout the community.

- Ebola Response Planning

The Board engaged in a discussion regarding current Ebola crisis. The Health Officer reported on the Department's activities. Preparations began in late summer with interagency planning sessions to coordinate a response county-wide. The situation is evolving often and rapidly. Significant staff resources are devoted to monitoring the evolving protocols provided by State and Federal agencies, updating community partners, and coordinating local response plans with County and local agencies.

Public Health Nurse's Report

September:

A report was given by Jamie Yates and discussed at length. 3 reportable diseases: 3 Investigations: 1 Hepatitis C, 1 Shigellosis, and 1 Varicella
54 immunizations. 14 screened for Hypertension.
