  - The Peddie School did an excellent presentation on what they are doing in Hightstown as well as this new initiative, Eliminating single use plastics in Hightstown. Each student and their teacher gave an excellent overview of the basic steps involved in banning single use plastics. They have interviewed several local businesses and have a generally favorable response from them all. They are looking forward to surveying our residents and bringing this information to the council. They addressed all the areas, local communities such as Highland Park, Hopewell twp. and Lambertville as well as the actions that are currently being taken by the state. At least 32 local areas have passed local ordinances, they are hoping Highstown will become one of them. Some towns have received Sustainable Jersey Grants to purchase reusable bags and provide education for all residents. Each town's process was detailed by the Students. All of which used mostly volunteer labor with town support for the ordinance and enforcement. Options were discussed including surveys, temporary charges for plastic or paper bags with eventual removal of fees.

# **Shade Tree Matters:**

### a. Shade Tree Official's Report:

i. Received \$7,000 grant from NJDEP, must be matched by the EC which will require approximately \$3,000 in costs for trees with the balance of the matching costs in labor. This will fund planting of approximately 20 new trees in the Borough.
