## Ongoing & New Business:

### 1. JCPL Pole approval -

i. Approval granted for 28 poles; 25 banners have been purchased; 20 will be hung in the first wave, primarily along North Main, Mercer, and two on South Main (we cannot hang on Verizon poles, which includes many on South Main and all of Stockton-except by CCL). PO from Future Signs is \$3000 to install banners on 20 poles.

Installation will take place in 3-4 weeks. Police will be present to provide installation escort. Finalized poles will be marked with blue tape. Need to purchase stainless steel strapping and spray paint. We need 12'/pole of strapping x 20 poles = 240' of strapping. Estimated cost of strapping is \$100.

#### 2. New member invitation

- New member invited -Dennis Egan accepted, formed submitted, will be instated in January 2020.
- 3. Stockton street sidewalk Sidewalk between Center and Rogers decaying improper install, and next to Civil War Monument where new power pole was installed, bricks not relayed properly (photos available upon request). HPC is getting a quote for repair.
