Shade Tree Matters:

- There was a discussion on the Stockton Street construction (road and sidewalks between 130 and Dutch Neck Rd.). the new plan does not include new street trees. If we want trees on the Hightstown side we would need to obtain county approval.

Complete Streets Committee Update: Mobility Plan Implementation (recurring item on agenda). Last meeting was a discussion of the Master Plan, and next meeting that will likely continue.

Parks and Recreation Update:

- There was a meeting at Rocky Brook regarding construction of the structure in the park. The goal is to make it into an open air pavilion.
- Roger Cook Greenway: Michael will do a walk through to get some ideas for improvements or repairs.

Planning Board Update:

• Matt Morgan was present to discuss the Master Plan. This is a 10 year re-examination report. It's a vision document and is not binding. It serves as a legal foundation for decisions. Matt

reviewed the portions pertaining to EC. The Planning Board is looking for comments on the

document, as well as provide some feedback on what is missing. We can send our comments to Matt and he will bring it up to the board. Soft deadline is end of the year 2023. Matt has put together a condensed document and put it in a Google doc. The second part of our action items is a survey, which can be completed as a group.

- David will also distribute Environmental Resource Inventory document from 2012.
- There was discussion to put items in the master plan to provide basis for grants and funding, e.g. net zero goals.

- Peddie Lake dam: sluice gate broke and was not able to be opened. They fixed it but will be good for 10 years. The gate need to be replaced eventually.
