APPLICATION for CERTIFICATE of COMPLIANCE SALE/TITLE TRANSFER

This form, payment of appropriate fee (see schedule below) and all certifications must be completed and submitted to the Code Enforcement Office to be considered. Certifications required for application completeness:

- Furnace/Boiler certification or checklist completed by a licensed HVAC or plumbing contractor.
- Level 2 wood-burning fireplace chimney certification (if applicable) by a Nationally certified Chimney Sweep Contractor. LEVEL 2 IS REQUIRED.

Upon receipt of the completed application packet, a representative from the Borough will contact you to coordinate scheduling an inspection. If the property is vacant, you may provide a lockbox code for access. A property with open permits may result in a delay of the issuance of Certificate of Compliance.
