OLD BUSINESS

- Vision Zero **Bev reported on NJ pending legislation, the Target Zero Commission Bill, which will create a State Commission to advise NJ DOT on implementing a Vision Zero-based transportation planning strategy. This will include coordination across 13 NJ agencies, dialog with families impacted by serious injuries and deaths, implementation of the Federal Highway Administration "safe systems approach," prioritizing safety, inclusivity and equity, creation of a public data portal for crash data and will require annual reports on implementation for true accountability. Steve will forward the information to Council.**

- **NOTE: Bill received final approval at the end of December (Assembly Bill Number A1476, Senate Bill Number S361). There was no opposition in either the Assembly or the Senate.**
- **Discussion: Recommendations to Council/Annual Report The Committee reviewed and made edits to the draft report. Steve will share with Council and ask to be added to the agenda for a meeting in January to review.**
